

## INSTRUCTIONS TO SG ATOM TO ESTABLISH DAILY FUNDS TRANSFER LIMITS FOR PIN-DEBIT CARDS OR SELF-EXCLUSION

The undersigned ("*Cardholder*") holder of the pin-debit card(s) specified below (each, a "*Card*" and collectively, the "*Cards*") hereby instructs SG Gaming, Inc., and its affiliates ("*AToM*") to limit the electronic funds transfers using each Card ("*Funds Transfers*") at the daily limit specified for that Card below ("*Daily Limit*"), in accordance with Nevada law. The selected Daily Limit will apply to the aggregate of all Funds Transfers initiated at all gaming establishments in the State of Nevada. A Daily Limit set at zero dollars (\$0) for any Card will preclude Funds Transfers from occurring at all using that Card. The Daily Limit does not include any fees charged by AToM or the gaming establishment for processing a Funds Transfer. Cardholder's request shall become effective upon AToM entering the Card information and corresponding Daily Limit into its computer system. Requests made pursuant to these instructions may take up to Five (5) business days from the date received by AToM to be processed and entered into the system. No sooner than 24 hours after these instructions become effective, Cardholder may withdraw these instructions. However, if Cardholder does not withdraw these instructions or change any Daily Limit for each Card by submitting a new set of instructions. However, if Cardholder does not withdraw these instructions or change any Daily Limit, the instructions shall remain in effect until such time that the Card or the ATOM system no longer is in use.

Cardholder represents and warrants that Cardholder has all right, power and authority to give these instructions on behalf of all joint holders of the Cards. Cardholder authorizes AToM to obtain credit reports using the information provided herein for the purpose of verifying the Cardholder's identity and authority. Cardholder agrees that AToM's acceptance of these instructions is strictly an accommodation to Cardholder, without any consideration to AToM. Therefore, in no event shall AToM be liable for its acceptance or rejection of, or compliance or noncompliance with, these instructions or any change to or withdrawal thereof for any reason whatsoever. Cardholder hereby waives any and all claims against AToM in connection with these instructions, including without limitation any denial or reduction of Funds Transfers pursuant to the instructions, AToM's failure to comply with the instructions, or any denial or reduction of Funds Transfers prior to the effectiveness of any change to or withdrawal of these instructions, and Cardholder further agrees to indemnify AToM against any liability arising from or relating to these instructions or any change to or withdrawal thereof, including, without limitation, any liability to any joint holders of the Cards; cards authorized by Visa U.S.A. Inc., Visa International, MasterCard International Incorporate, Discover Card, American Express, Star, Interlink, Maestro, NYCE, Pulse, AFFN or other pin-debit networks (collectively, the *"Authorizers"*); the issuers of the Cards; any acquiring or merchant bank involved in the processing of Funds Transfers involving any of the Authorizers; or any gaming establishment.

By signing below, Cardholder hereby agrees that this request and any revocation thereof shall be governed in all respects by Nevada law without regard to any choice of laws provisions. Cardholder agrees that any claim or controversy arising out of this request or any revocation thereof shall be settled by final and binding arbitration to be held in the State of Nevada by a single arbitrator in accordance with the Commercial Arbitration Rules of the American Arbitration Association. Judgment on any award rendered by the arbitrator may be entered in any federal or state court located in the State of Nevada. Should AToM prevail in such action, the arbitrator shall award to AToM all costs, fees and expenses of the arbitration, including attorneys' fees.

Card numbers will be processed as provided by the Cardholder below. The Cardholder must include any and all leading zeros for Card numbers. In the event any information provided by Cardholder below is no longer accurate, it is the Cardholder's responsibility to submit to AToM new instructions to establish a Daily Limit with updated Card numbers. This information will remain confidential and will be used solely for the purposes described above. Cardholder acknowledges and agrees that incomplete forms cannot be processed and will result in AToM's rejection of these instructions, without notification to Cardholder.
