LAS VEGAS and CHICAGO, Dec. 14, 2017 /PRNewswire/ -- SG Interactive, a division of Scientific Games Corporation (NASDAQ: SGMS) ("Scientific Games" or the "Company"), announced today that the Company's titles launched in Italy on November 27, marking the first time SG Interactive games are accessible in the regulated Italian market.

The initial offering is available first with Betsson Group's StarCasino.it, and other clients including Snai, Sisal and Bwin will follow. The Company expects more partners to jump on board as the market continues to grow.

The Company's library has proven to be popular and successful in our other jurisdictions, and we're confident Italian players will be thrilled to have these themes available."
