The Betfred Sportsbook inside The Draft Room at Paragon Casino Resort, Marksville, is the first retail venue in the state to allow customers to place legal wagers on a variety of sports thanks to the latest partnership between Betfred Sports and Scientific Games' *OpenBet*.

The launch follows Louisiana voters' approval of legalized sports betting in a November 2020 referendum, which was passed into law in June 2021.

Billed as "the ultimate fan zone", The Draft Room is spread across 8,000 sq. ft. and contains betting counters and self-serving kiosks delivered by Scientific Games, all powered by $OpenBet^{TM}$, the industry's reliable and scalable betting engine that is celebrating its 25^{th} anniversary this year. Along with theatre seating and custom video walls, Betfred and Scientific Games are delivering a world class sports betting experience for Paragon Casino Resort customers.

The Tunica-Biloxi Tribe of Louisiana opened Paragon in 1994 and it serves as the largest employer in central Louisiana. The casino has contributed more than \$40 million to local communities through the gaming compact it reached with the state. The Class III casino is spread across 72,000 sq. ft. and amenities at the resort include a spa and golf course.
