



## **SEVEN LUCK CASINO IN SEOUL KOREA IS THE FIRST TO INSTALL SCIENTIFIC GAMES' QUARTZ® HYBRID**

The increased connectivity of *QUARTZ HYBRID* allows operators to link up to 50 individual live gaming tables.

The *QUARTZ HYBRID* terminal features HD graphics on a new 26.5” 1920x1920 resolution touch screen giving players a more immersive experience. Updated content includes a new player interface that adds game statistics as well as dealer activity display. Players can choose to view up to eight games at any one time on the single screen.
